Will the event be authorized to take place?

According to the current information, we will be authorized to gather 200 people in the main conference room. If needed, we will have access to a separate conference room able to accommodate an equal 200 number of attendees.

Priority attendance in the rooms will be granted on a "first registered, first seated" basis. Therefore, early birds will be assured of their seating as soon as they will register.

Coffee breaks and sandwich lunch will be organized in such a way that "Covid compliance" will be granted.

Will I be able to return safely to my country after the congress?

Belgium is a very hospitable country: we will be happy to have you here. Of course, we expect you to be able to get back to your country as safely as you came to Belgium.

According to the current situation and to the expected evolution in the weeks to come, we expect most countries not to set people returning from Belgium in quarantine. However, this information has to be monitored with the authorities of your home country.

Is an alternative in the form of videoconferencing planned?

For those who will not be able to travel to Malines, we are able to offer you to participate in videoconference mode.

We will of course keep you informed of changes to the program and the reception conditions.

We look forward to meeting you in Malines in a safe environment, and we are actively preparing this great opportunity to meet professionals, after difficult months.

We are counting on you to contribute to the realization of this conference, which will bring together quality speakers on the extremely central theme today of artificial intelligence and its concrete intervention in fields relating to judicial expertise.
