# *The experience of the Court of Florence was born from a concrete sharing project in the area*



Thanks to inter-institutional sharing and collaboration and with the intermediate bodies of the territory between these Civil Chambers and Ape Periti Toscana, a memorandum of understanding was signed to ensure better functioning of the civil process through the help of technical consultants, which was

presented to the community in an official event at the Pegaso room of the Tuscany region on 14 December 2017. After about a year from the implementation of the protocol, the register of expert witnesses of the Court of Florence had been improved and made more efficient with greater transparency of the information and skills available and substantial reduction of its population to offer a concrete possibility of rotation in positions and specialized expertise in the service of justice. The excellent result obtained was presented in a public demonstration in the Salone dei Cinquecento in Palazzo Vecchio in Florence hosted by the Mayor of the City on 25 October 2019 in the presence of the highest local judicial and government authorities and beyond

Among the main purposes of CONFGIUSTIZIA - National Confederation of Experts and Auxiliaries of Justice:

to cooperate with public or private bodies operating in the field of Justice, fostering their interlocution also in order to improve the current regulatory framework and to deepen the debate and the knowledge of the problems and critical issues pertaining to the issue of the entry of expert knowledge in civil and criminal proceedings and in executive, insolvency, ADR and extrajudicial procedures, in the delegations and functions mandated by the Judicial Authority
